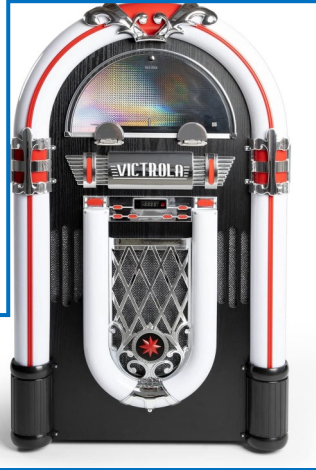
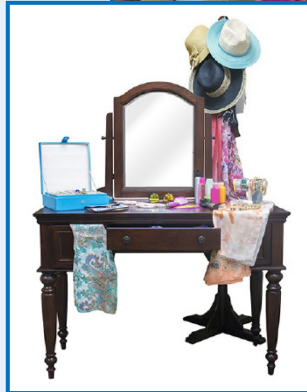
TECHNOLOGY TO PERSONALIZE EXPERIENCES
